# 12. CONSTITUTIONAL CHANGE (FIRST READING) - UNION COURT MEMBERSHIP

RECEIVED: The motion was presented by the RCC Chair.

#### NOTED:

a) Council moved to a vote and the motion was accepted unanimously.

## **RESOLVED:**

1) To change 4.1 (to be effective from 1<sup>st</sup> August 2007) to the following:

"Three full members of the union, elected by council".

4. The Court shall consist of members appointed in the following manner:

- 1. Three Full Members of the Union, elected by council.
- 2. Three Full Members of the Union nominated by the Executive Committee and approved by the Council,
- 3. Three Life Members of the Union nominated by the Executive Committee and approved by the Council,
- 4. One member of the academic, academic-related or senior administrative staff of Imperial College, of a rank equivalent to that of Senior Lecturer or above, nominated by the Council and approved by the Rector.

# 13. CONSTITUTIONAL CHANGE (SECOND READING) - TIDY UP

RECEIVED: The paper was presented by the President

#### NOTED:

- a) Discipline is now dealt with through Court and Council
- b) College have agreed to accept the usage of Faculty Unions' names.
- c) Council moved to a vote and it was agreed unanimously to accept the paper.

#### **RESOLVED:**

1) To remove references to disciplinary matters from the following section of the constitution:

## Paragraph 10

- 4. The Executive Committee shall:
  - a. Advance the aims and objects of the Union,
  - b. Implement Union policy,
  - c. Set operational policy in line with Union policy,
  - **d.** Oversee the day-to-day running of the Union and the co-ordination of its activities.
  - e. Establish policy on staffing issues and oversee staffing matters,
  - **f.** Establish policy on health and safety issues and oversee health and safety matters.
  - g. Deal with disciplinary matters in accordance with policy,
  - **h.** Establish principles for the fair allocation of the resources available to the Union,
  - i. Monitor financial performance against budget,
  - j. Receive the audited annual accounts of the Union and report their findings to the Council,
  - **k.** Monitor the performance of the trading outlets, services and retail facilities of the Union, and
  - I. Act as trustees of the Union.

# 2) References to Faculty Unions in Regulation One and Regulation Three should be changes accordingly:

From "Imperial College Faculty of Engineering Students' Union" to "City and Guilds College Union".

From "Imperial College Faculty of Medicine Students' Union" to "Imperial College School of Medicine Students' Union".

From "Imperial College Faculty of Natural Sciences Students' Union" to "Royal College of Science Union".

The following section of Regulation Three to be amended accordingly:

The Faculty Unions shall consider welfare and academic affairs issues relating to students at those respective faculties and shall provide for the co-ordination of student activities within their Faculty.

The Faculty Unions are the governing committees of their clubs and societies, and their decisions are binding upon clubs and societies administered by them.

## The Faculty Unions are:

- a. The Imperial College Faculty of Engineering Students' Union City and Guilds College Union, for the Faculty of Engineering.
- b. The Imperial College Faculty School of Medicine Students' Union, for the Faculty of Medicine.
- c. The Imperial College Faculty of Natural Sciences Students' Union Royal College of Science Union, for the Faculty of Natural

# 14. CONSTITUTIONAL CHANGE (SECOND READING) - CAMPAIGNS OFFICERS

#### NOTED:

- a) The membership has been amended to remove Faculty Union Presidents.
  - i. This was suggested and agreed at the last Representation and Welfare Board.
  - ii. The reasoning behind this decision is due to that Faculty Union Presidents have not attended a single Representation and Welfare Board meeting since its inception.
  - iii. The ICSMSU President expressed his dissatisfaction that the Presidents had not been consulted before this decision and feel that they should have been.
  - iv. The Deputy President (Education & Welfare) stated that the Faculty Union Presidents were able to attend as observers and it was unclear why they were on the committee in the first instance.
  - v. Welfare and academic representatives from all faculties are members of the committee.
  - vi. It was suggested that the Faculty Union Presidents are included as permanent observers to the committee.
- b) The President changed 'Membership, point 26' to read:
  - 26. The Representation and Welfare Board shall be chaired by the Deputy President (Education & Welfare) and have a quorum of half all non coopered members.
  - i. There were no objections to this change.

### **RESOLVED:**

- 1) To change 'Membership, point 26' to read:
  - 26. The Representation and Welfare Board shall be chaired by the Deputy President (Education & Welfare) and have a quorum of half all non co-opted members.
- 2) To add Faculty Union Presidents as Permanent observers to the 'Membership' thus to read:
  - 27. The Faculty Union Presidents shall be permanent observers.
- 3) To accept the paper and amend the Constitution as follows:

## Representation and Welfare Board

## Powers and responsibilities

- 20. The Representation and Welfare Board shall co-ordinate, manage and act as a forum for issues relating to student welfare, academic affairs, accommodation, representation, campaigns, diversity and equality.
- 21. The Representation and Welfare Board shall allocate funding for the better provision of such services and campaigns as it deems fit, subject to Union or operational policy, in particular the Union's policy on the fair allocation of resources.
- 22. The Representation and Welfare Board shall determine policy within its operation, subject to Union policy and operational policy. It may only approve any policy stating the views of the Full Membership or committing the Union to a political position with the approval of the Council.

- 23. The Representation and Welfare Board shall have the power to create and assign campaigns portfolios to any officer or co-opted member of the committee. The job descriptions pertaining to these portfolios shall be defined in policy.
- 24. The Representation and Welfare Board shall report its business for approval by the Executive Committee and the Council.

#### Membership

- 25. The Representation and Welfare Board shall consist of:
  - 1. The Sabbatical Officers,
  - 2. Equal Opportunities Officer,
  - 3. Welfare Campaigns Officer,
  - 4. A representative appointed by the Overseas Societies Committee,
  - 5. The Faculty Welfare Officers,
  - 6. The Faculty Academic Affairs Officers (Taught Students),
  - 7. The Faculty Academic Affairs Officers (Research Students),
  - 8. A representative appointed by the Halls Committee.
  - 9. Such additional members as the committee may co-opt.
  - 10. The faculty Union Presidents shall be permanent observers.
- 26. The Representation and Welfare Board shall be chaired by the Deputy President (Education & Welfare), and have a quorum of half all non co-opted members.

# 15. CONSTITUTIONAL CHANGE (SECOND READING) – NUS AND ULU DELEGATES

RECEIVED: The paper was presented by the RAG Chair

### NOTED:

a) Council moved to a vote on accepting the paper and it was accepted unanimously.

#### **RESOLVED:**

# 1) . To insert the following paragraph into Regulation 1 (Officers of the Union Regulations)

F. Job Descriptions for delegates:

Delegates elected to represent the Union to the National Union of Students (NUS) and the University of London Union (ULU) shall:

- i. Attend all Union relevant meetings and represent the views of the Union to the NUS National Conference and the ULU Council.
- ii. Work with all other Union delegates to support motions that the Union Council believes further the aims, objects and policies of the Union.
- iii. Work with all other Union delegates to prevent motions that the Union Council believes work against the aims, objects and policies of the Union from being passed.
- iv. Be forbidden from joining any NUS or ULU political or religious faction.
- v. Where clarification is required on matters concerning 32.i to 32.iv, the delegate shall seek instruction from the Union President.
- Any NUS National Conference delegate who fails to attend the NUS National Conference without giving ten College day's notice and a reason to the satisfaction of the President or, in the view of the Council expressed through a disciplinary motion, fails to fulfil the tasks outlined in 32 shall be forbidden from running for NUS Conference positions again.
- Any ULU Council delegate who fails to attend two ULU Council Meetings without giving five College day's notice and a reason to the satisfaction of the President shall be deemed to have automatically resigned from their position and will be forbidden from running for ULU Council positions again.

# 2) Insert the following paragraph into Regulation 2 (Elections and Referenda Regulations)

33. The Union's delegates for the National Union of Students' National Conference shall be the President and other delegates elected by and from the Full Membership by College-wide secret ballot during the Spring Term on dates approved by the Union Council. Should a delegate resign ten or more College days in advance of the NUS National Conference or any ULU Council meeting then the President shall appoint a replacement and report his or her

decision to the following Union Council Meeting. The Union Council may appoint an observer to attend the NUS National Conference and report on its outcomes and the conduct of Union delegates to the first Union Council meeting of the Summer Term.

### 16. NUS CONFERENCE AMENDMENTS - HIGHER EDUCATION FUNDING

RECEIVED: The paper was presented by Camilla Royle

## NOTED:

- a) Point of order was called from the floor in that the paper was without seconders which are required under Regulation 4, 64 of the Union Constitution.
  - i. After debate, the Deputy President (Finance & Services) stated that he would second the paper and Council deemed this acceptable.
- b) The Chair reminded Council to speak sensibly throughout the debate.
- c) It was questioned what the origin of the motion was.
  - i. Camilla Royle stated that it has been acquired through the 'Student Respect' website.
- d) It was questioned if the wording can be changed to make it more relevant to Imperial College Union members.
  - i. Camilla Royle was extremely hesitant to accept any amendments and stated that the purpose is to give gravity to the motion by many Universities submitting the same motion.
- e) It was questioned why Imperial College Union should send in the same motion to NUS Conference.
  - i. The President outlined the process of submitting motions to NUS Conference and explained that similar motions are complied together in a process referred to as 'compositing'.
- f) It was reminded that this motion is not binding on ICU policy; it is a motion to the NUS.
- g) It was argued that the motion does not represent Imperial College Union Members.
- h) Council moved to a vote on accepting the paper and rejected unanimously.

### **RESOLVED:**

1) To reject the paper.

## 17. ANY OTHER BUSINESS

# 17.1 NUS CONFERENCE AMENDMENTS - INTERNATIONAL MEDICAL STUDENTS

RECEIVED: The paper was presented by the ICSMSU President

# NOTED:

- a) The law has changed in that International students will not be able to practice in the UK after their foundation years have been completed.
- b) The ICSMSU President stated that students who came to Imperial College 6 years ago under the assumption that they were able to practice medicine in the UK after graduation.
- c) Council moved to a vote to accept the paper and it was accepted unanimously.

## **RESOLVED:**

1) To work with relevant organisations in lobbying the Government to allow all current medical students from non-EEA countries to complete their training in the UK.

## 17.2 NUS CONFERENCE AMENDMENTS - ACCESS TO RIVERS

RECEIVED: The paper was presented by the RCC Chair.

### NOTED:

- a) The appendix was passed in part by last years Council but this has now been updated to reflect the updated information.
- b) The Deputy President (Clubs & Societies) expressed concern that the motion is 'piggybacking' another paper that is going against BUSA beliefs.
  - i. The Deputy President (Clubs & Societies) explained that the paper tries to get an NEC member to look after activities including sports and NUS believes that sports representations should be handled by the NUS, which is in conflict with BUSA.
  - ii. This was discussed at great length at BUSA divisional and national meetings and questioned if the Union should be piggybacking the paper which we may not agree to in principle.
  - iii. The Deputy President (Education & Welfare) stated that the motion may not 'piggyback' the paper after compositing occurs.
- c) Council moved to a vote and it was accepted unanimously.

## **RESOLVED:**

- 1) The activities officer will co-ordinate national campaigns on relevant issues including, but not limited to, campaigning for unrestricted access to Britain's inland waterways.
