## **Clubs and Societies**

The Finance Manual was completed a few weeks ago and there are a small number of printed copies available from the SAC. I have met with a large number of clubs to assist with their event planning and I am swimming in sponsorship contracts. The start of this year has also seen a huge number of applications for mailing lists and login requests, partly to do with the number of new clubs formed. I am currently resolving a number of issues from last year as well as a few issues with the transactions pages. Sponsorship, event budgets and contracts/agreements are currently taking up a vast proportion of my time as they are still being received in some volume.
