4. STANCE ON CHANGES TO THE IMMIGRATION BILL

RECEIVED: The paper was presented by the President

- a) The presented paper is the redraft of the original paper that was rejected at the last meeting of Council.
- b) Thanks were given to the Deputy President (Welfare) and working group for their swift turn around on the paper.
- c) 120 responses were received on the survey that was sent out.
 - i. The survey was unable to be included in the 'all student email' due to timelines but it was promoted through all social media.
 - ii. The Union does not have an email list of just International Students.
- d) It was suggested that the Union lobby for just ICU students to be excluded from the Bill however it was pointed out that this would be impossible.
- e) There is currently no legislation for Landlords to carry out any checks on students. Any that do occur are down to the landlords own procedures.
- f) Council voted on passing the paper presented at this meeting, and the vote is as follows:

RESOLVED:

- 1) **Imperial College Union should oppose and actively campaign against the Immigration Bill as long as International Students are not exempted from paying for medical treatment.**
- 2) **Imperial College Union should join with relevant parties, such as the NUS or other London Unions, to help campaign on this issue.**
- 3) **In parallel to direct action against the proposed Bill, the Union should work with College to ensure measures are in place to mitigate the effect of this Bill, such as publicising the Hardship Fund and working in partnership with the International Office, to ensure students struggling to pay these fees can access financial aid.**
- 4) **Imperial College Union resolves to oppose and actively campaign against the Immigration Bill as long as landlords will be obliged to check the immigration status of International Students.**
- 5) **Imperial College Union should investigate ways that the College could support International Students facing these checks.**
