## 18. HIGHER EDUCATION FUNDING POLICY

a) Andrew Tranter suggested taking the question of HE funding to Referendum as he believes that this is an important topic and the student body should have the opportunity to feed in their opinions.
b) It was stated that there was a presentation at Council and the student body were asked through the Union Newsletter and Felix to feed their opinions which some did so and these were included in the creating of the presented policy.
c) It was highlighted that if the policy isn't passed, the Union will be without a Higher Education Policy which is a dangerous position to be in especially leading up to the General Elections.
d) It was suggested that the Summer Term is not the best time for student consultation and if it is felt that Council is not a representative body then refer to referendum.
e) It was suggested that 3 options should be asked to the student body should it go to referendum.
f) The option could be to extend the current policy or pass the new policy but include a clause for this to expire at the end of December 2014.
g) It was put to a vote in a Council wanted to take the discussion on Higher Education policy to a referendum and the vote is as follows:

## 19. SABBATICAL ROLE REVIEW

RECEIVED: The paper was presented by the Sabbatical Officers

## NOTED:

a) All Sabbaticals are now Officer Trustees which is the first full year that this is the case. Before the change to the constitution, the President was the only sabbatical who sat on the Board of Trustees.
b) The paper is in two parts - the roles and the names.
c) The Bye Laws are currently being looked in to by the Governance committee.
d) Alex Savell proposed a change to point x.ii where this should be removed for the general role and moved specifically to the Deputy President (Finance \& Services)
i. All officers have a service and events element to their roles and as such should remain as a general role. The officers have been in term this year to recognise that this is the case.
ii. The change to the Deputy President (Finance \& Services) role have been to reflect how the role has evolved and takes nothing away from the interactions between the Deputy President (Finance \& Services) and commercial services and financial responsibilities.
iii. It was highlighted that the role descriptions are the minimums of what is expected from the officers and that each bring their own strengths and values to the role.
iv. Officers Trustees are equally financial liable and as such this needs to be reflected in the general role description.
v. Council moved to a vote on passing the presented changes to the Bye Laws and the vote is as follows:

e) In regards to the name changes for the role for Deputy President (Finance \& Services) and Deputy President Clubs \& Societies, the following discussion took place:
i. Changes to the names will not come in to effect until advertising for the Big Elections 2015 commences.
ii. It was suggested that 'Finance' and Development' comes before Activites in the name so it indicates more clearly what the roles are.
iii. The Deputy President (Finance \& Services) and Deputy President Clubs \& Societies roles overlap a lot and students will often contact both officers with queries.
iv. Significant amounts of controls is given to clubs and they need support both from sabbaticals and staff.
v. There has been a lot of discussing in regards to the names and the presented changes are the most appropriate.
vi. There is anecdotal evidence that students stand for the role of Deputy President (Finance \& Services) without knowing exactly what the role is despite there being a plethora of information available to candidates. The survey undertaken last year indicated that students feel that 'development' should be included in the Deputy President (Clubs \& Societies) role and so this should be reflected in the name.
vii. Council moved to a vote on passing the presented name changes and the vote is as follows:

D. Officers of the Union

1. The Officers of the Union shall be the:

### 1.1. Officer Trustees:

1.1.1. President,
1.1.2. Deputy President (Clubs \& Societies),
1.1.3. Deputy President (Education),
1.1.4. Deputy President (Finance \& Services),
1.1.5. Deputy President (Welfare),

## Job Descriptions for the Officer Trustees

x. Beyond their responsibilities as Trustees all Officer Trustees shall;
x.1. Act as a Trustee ex-officio,
x.2. Fulfil all Presidential and constitutional responsibilities,
x.3. Execute and develop policy and further the aims and objectives of the Union,
x.4. Ensure that all members of the Union are equally represented,
x.5. Chair relevant Union Committees,
x.6. Liaise with Union and College staff as appropriate,
x.7. Represent the Union on external committees as appropriate,
x.8. Report to Union committees as appropriate,
x.9. Negotiate extra duties where appropriate,
x.10. Coordinate the work of the non- Trustee officers of the Union,
x.11. Ensure that the Union provides relevant and sustainable events and services that meet the demands of its members,
x.12. Campaign, where appropriate, on issues relevant to the membership.

## President

8. The President shall;
8.1. Be the chief executive officer of the Union,
8.2. Be responsible for constitutional development and preliminary interpretation,
8.3. Be responsible for the Managing Director,
8.4. Be responsible for coordinating the work of the officer trustee team,
8.5. Take on or delegate Presidential duties where appropriate,
8.6. Be responsible for representing the Union to the local community and external bodies,
8.7. Be responsible for the effective coordination of activities and representation at nonSouth Kensington Campuses in conjunction with the relevant officers and Union committees,
8.8. Ensure the adherence to the Complaints and Discipline procedures set out in Section $E$ of the Bye-Laws.

Deputy President (Clubs \& Societies) (to be renamed the Deputy President (Activities \& Development) for Big Elections 2015)
9. The Deputy President (Clubs \& Societies) shall:
9.1. Take on Presidential duties as appropriate,
9.2. Be responsible for the effective coordination and representation of Clubs, Societies \& Projects, in conjunction with the relevant Union committees,
9.3. Liaise with Union staff to ensure that appropriate support is being given to all Clubs, Societies \& Projects,
9.4. Represent Union Clubs and Societies to British Universities \& Colleges Sports (BUCS).
9.5 To be jointly responsible for the sustainability, training and support of volunteers.

## Deputy President (Education)

10. The Deputy President (Education) shall
10.1. Take on Presidential duties as appropriate,
10.2. Be responsible, for reporting to the College student opinion on academic affairs, suggesting areas for development, and enhancing the student experience and provision for students,
10.3. Be for responsible for the training and running of a Representation Network for the Academic Representatives of the Constituent Unions and other student bodies,
10.4. Liaise with the Constituent Unions on all academic matters concerning students,
10.5. Support Student Enterprise and Innovation within the Union and the College.

## Deputy President (Finance \& Services) (to be renamed the Deputy President (Activities \& Finance) for Big Elections 2015

11. The Deputy President (Finance \& Services) shall:
11.1. Take on Presidential duties as appropriate,
11.2 Be responsible for providing support on Financial matters to Clubs, Societies \& Projects,
11.3. Be responsible for the adherence of Clubs, Societies \& Projects to the Union's Financial Procedures,
11.4. Be responsible for the effective coordination and representation of student skills development and accreditation programmes operated by the Union,
11.5 To be jointly responsible for the sustainability, training and support of volunteers.

## Deputy President (Welfare)

12. The Deputy President (Welfare) shall:
12.1. Take on Presidential duties as appropriate,
12.2. Be responsible for identifying and informing College of student opinion on welfare issues and suggesting areas for development, and for coordinating and publicising all campaigns concerning:
12.2.1. equal opportunities and welfare issues,
12.2.2. volunteering opportunities.
12.3. Be responsible for representing the welfare needs of all students, especially minority or under-represented groups to the College,
12.4. Be responsible for maintaining and running a Welfare Network with the Union and Constituent Union Liberation Officers,
12.5. Be responsible for providing support to student led campaigns.
