### 1. Note:

## 2. Welcome Week:

- 2.1. I mentioned this at the last meeting but I'm putting it down slightly more formally
  - 2.1.1. I and other Officer Trustees attended a number of Fresher's Week events as part of our role in my case:
    - 2.1.1.a. Mingle and MingleLite in the Union and JCR
    - 2.1.1.b. Live Comedy in Metric
    - 2.1.1.c. Freshers' Fair after party (Metric) and Live Comedy in h-Bar
    - 2.1.1.d. Acoustic Night (h-Bar)
    - 2.1.1.e. Freshers' Ball (Union), ICSMSU Roadshow (Reynolds) & Relaxed Club night (h-Bar)
    - 2.1.1.f. ICSMSU Sports Day (Teddington)
    - 2.1.1.g. Dri (Union)
  - 2.1.2. All events were generally well attended and the response to the live acts was in general extremely good. Some lessons to learn though are:
    - 2.1.2.a. With enhanced PG engagement during the Welcome Week period the PG Mingle at the end of the week had less attendance
    - 2.1.2.b. A central minibus provision for key events was useful but needs to be more extensive/communicated
    - 2.1.2.c. Metric usage at Dri is difficult to encourage. Focussing on 568 and the Union bar would be more effective
