#### 1. Chairs Business

### 1.1 NAC / ADB Updates

# 2. Minutes of Meeting – 16 June 2015

a) It is noted that the minutes of the last meeting were not presented to the board, this will be carried over to the next meeting

# 3. Matters Arising

- a) It is noted that Media would like to propose the closure of the Magazine club
- b) It is noted that Magazine Club have no committee and have not been active for the last two years
- c) It is noted that they have 0 members
- d) It is noted that Magazine Club have £120 in their account
- e) It is proposed to move the leftover funds to the Media Exec Account
- f) The board then moved to a vote to close down the Magazine Club

#### Resolved:

- a) The board moved to a vote to accept the closure of Magazine Club
- b) The vote passes with 1 abstention
- g) The board then moved to a discussion over the reallocation of Magazine Club's remaining funds
- h) There was discussion around the funds being redistributed to the Activities Development Fund, or the Media Exec account
- i) It was questioned by A&E if this proposal (redistribution of funds) would be arbitrary for the rest of the year
- j) The Deputy President (Clubs and Societies) suggested that this needs further discussion of it is going to be a rule within the board

### Resolved:

# 4. Finance Report

### 5. Tours Policy

### Matters for Discussion

## 11. Budgeting Policy Brief

- a) The Deputy President (Clubs and Societies) gives out background on budgeting policy
- b) Going to be reviewing how we fund clubs in general
- c) It is noted that the whole board is interested in this review
- d) It is noted that this will be brought to the December meeting

### 11.1 High cost activities

- a) It is noted that a few clubs (5%) have 75% of the budget. Examples are Riding and Polo, Underwater, Canoe etc.
- b) The board discusses whether it is possible to fund clubs in general to a specific point and stop, or do we value high cost, impressive activity which is important when we sell the union to existing students
- c) It is noted that more students benefit at low cost
- d) It is discussed how prioritising low cost and measure their impact
- e) It is noted that you can bring the cost of cheap activity down substantially through funding, however bringing the cost down for high cost activity is extremely difficult
- f) It is noted that it is important to recognise that some activities are more expensive than others
- g) It is noted that some high cost clubs only exist because they are historical and if they were created now, they would not be approved

- h) It is noted that higher cost activity should seek for more funding through sponsorship rather than through budgeting
- i) It is noted that if we use flagship societies in our marketing, this is not reflected in their membership, i.e. the higher cost activities do not have a lot of members
- j) It is noted that if someone has tried a high cost activity before they joined Imperial, that they have paid the cost of that activity prior to its subsidy before and could therefore pay for it again
- k) It is discussed whether high cost activities allow people to try something new, or if it is just for people who are already experienced
- I) It is noted that 20% funding for some high cost activities is not a lot at all

# 11.2 Ring Fencing Motor Clubs & Silwood & Community Welfare Board

#### **Motor Clubs**

- a) It is noted that the Vehicles have been around for 60+ years and have a great reputation with College
- b) It is noted that Motor Club cannot charge for anything because it is against policy and so cannot get funding from anywhere
- c) The board then moved to a vote to accept the Motor Club ring fence

#### **RESOLVED:**

a) The vote passes unanimously

#### Silwood

- a) The Deputy President (Clubs and Societies) explains the Silwood Campus and their need for ring fencing
- b) The board then moved to a vote to accept the Motor Club ring fence

# **Community Welfare Board**

- a) It is noted that more discussion is needed as the board have a mixed view
- b) It is noted that this will be brought to the next meeting

#### 11.3 Inflation

- a) It is noted that last year different Management Groups were saying different amounts of inflation to their clubs
- b) It is important that all Management Group chairs know which exact amount of percentage of inflation it is

# 11.4 Subsidy available for minibuses

- a) The Deputy President (Clubs and Societies) gives some background to the board
- b) It is noted if there is potential to look into nature of activity as minibus use widely differs
- c) It is noted that minibuses inside London should have less subsidy
- d) It is noted that this will be carried over to email to be discussed further

#### **ACTION**

a) The Deputy President (Clubs and Societies) to send email out o those interested in this discussion

### 11.5 Sports facility hire

a) It is noted that RCC, ISCM, ACC would like to be involved in this decision

# 11.6 High SGI/DMF's

- a) Some background was given on clubs with high amounts of Self-Generated Income
- b) It is noted that we should not penalise clubs for being entrepreneuring but there needs to be a balance
- c) It is noted that this should be a club by club basis e.g. when saving for something
- d) It is noted that we should clearly state that DMF's are not included in budgeting
- e) There was a discussion on how much clubs with high SGI are penalised during budgeting
- f) It is noted that this needs further discussion

## 11.7 Health and Safety

- a) It is noted that this presents a significant risk if not done right (i.e. clubs not funded enough to make their activity safe with certain equipment etc.)
- b) There was a discussion around the definitions of health and safety
- c) The Deputy President (Clubs and Societies) asks the board to talk with their committee and bring this back to the board

# 11.8 Committee and personal level funding

- a) It is noted that Can't spend grant to benefit committee/specific members
- b) Exceptions to benefit members for training, on the basis they provide training for the rest of the club
- c) Affiliate membership of their local golf club otherwise can't participate in club activity

### 11.9 Publicity and Printing

- a) The question is asked to the board if we want to fund CSP's to do printing at all?
- b) It is suggested that publicity should be factored into event budgets and covered in the cost
- c) It is noted that if we are considering external printing sources, this needs to be considered with the board.
- d) It is noted that it is important to distinguish whether printing is necessary for the activity of the club.
- e) It is noted that free club printing caused a huge waste of paper
- f) It is noted that the amount allocated to clubs currently (£10) is very reasonable for some clubs, but not for others

# 11.10 Criteria for funding

- a) The Deputy President (Clubs and Societies) discusses the points made on the slide
- b) The Deputy President (Clubs and Societies) would like the board to prioritise the points discussed

# 11.11 Management Group chairs present at all budgeting discussions

- a) It is noted that ACC do not have much experience with performance rights etc., and vice versa
- b) It is noted that all Management Group Chairs sit on the board to represent all Club, Society and Project activity
- c) It is noted that members of the board have a collective responsibility

# 11.12 Constituent Union funding (telephones)

#### ACTION:

The Deputy President (Clubs and Societies) to make sure funding for telephones and other constituent union equipment is on the agenda for the next meeting

## 11.13 Consideration of College funding

- a) It is noted that this is similar to sponsorship.
- b) It is noted that this has particular effect on Departmental Societies
