11. Union Awards Policy

B. Discussion:

- i. The distinction between Honorary Life Membership and awards was clarified. Honorary Life Membership being paid and award being given to volunteers.
- ii. There was a discussion of the spectrum of being a volunteer and a paid member of the union with regards to awards
- iii. There was a discussion of the structure of group structures of Constituent Unions and management group, with a reflection of the decisions made at last council.

12. Proposal to Improve Accessibility of Union Activities for People Who Are Neurodivergent

- A. Received: The paper and the reading list was summarised and presented by the Mental Health Officer
- B. Discussion
 - i. It was clarified that 2 hour meetings means 2 hours of activity, therefore can be longer than 2 hours. This time period is only a recommendation by charities.
 - ii. There was a further discussion on the recommendation and how up to date the document is, concluding that is may not be up to date.
 - ii. There was a discussion on the paper including the stimulus of the recommendation of yellow paper, the recyclability of the paper and the feasibility of the paper. This concluded that the feasibility of the paper will need to be researched.
 - iv. Suggested amendment to remove clause 2 to allow flexibility.
- Resolved: To accept the paper with the suggested amendment to remove clause 2 –

A. Received: The Chair summarised and present the paper. The Council Ordinary Member (UG Engineering), Joseph El-Kadi, made a statement in their own defence. As The Chair was presenting the paper they stepped down from their positions the RCSU President volunteered to be chair.

- i. The council member agreed to adhere to Chatham house rules
- ii. There was a discussion of the term "motion of no confidence" with no real answer arising.
- iii. It was clarified that the Union did not investigate the case. Clause 6 a. will be amended to state that the Union did not investigate the case.
- iv. It was raised that the stats were incorrect and will therefore need to be amended with the correct number of emails sent of 500 600.
- v. The Felix Editor read out a statement by the Chair of MechEng Society. Please see paper... for the statement)
- vi. There was vote to extend the meeting by 10 minutes.

Accept: 76.67% Reject: 20% Abstain: 3.33%

- vii. There was a discussion of the elections complaint procedure and timeframe. In light of this it was felt that a better system of protection is needed. Therefore it was noted that this issue will be taken to the Governance Steering Group.
- viii. The union notes that this is only procedure for this kind of case. It is regrettable that this is process and it is not the belief that this individual cannot fulfil the role, it is an error in the system.
- ix. Both parties closed with a final statement.
