Discussion: Breadth of Sources of Council Business

Introduction: Across the 5 Council Ordinary Meetings this year, no matters for decision / discussion have come from Council Members other than: Council Chair, President, DPW (if ratification of CU constitution changes is excluded). This is unusual, and a sharp decline from previous years which saw submissions from: 13 (2018/19), 10 (2017/18), and 9 (2016/17) unique Council members across the first 5 meetings, for a total of: 16 (2018/19), 17 (2017/18) and 8 (2016/17) submissions from outside of Chair + OTs. There has also been a drop-off in submissions of business from non-members of Council. This has been reflected in a perceived lack of diversity in Council business this year.

While it has always been the case that the majority of Council Members do not submit any items of business over the year, the Chair is concerned by the sharp decrease this year and would encourage feedback from Council along the following lines:

Points for Discussion:

- 1. Do Members feel confident that they would be able to submit a matter for discussion or decision, should they feel the need to? i.e. do they feel that they understand the process for submitting a paper, and they would be supported in submitting a paper if they chose to?
- 2. Do Members feel that they understand the sorts of matters that might be brought to Council, and can they think of examples of such matters that might lie within their remit?
- 3. Are Members reluctant to bring matters to Council because they feel they would be better dealt with at a Council subcommittee?
- 4. What could be done going forward to encourage more participation and submissions from the wider Council membership?
