## **Key themes:**

## Council membership:

- What groups need to be represented on Council?
- How should Council membership be allocated? (e.g. designated roles vs more flexible allocation from CUs / subcommittees etc)
- Are any changes needed to Council subcommittee membership?

## Council effectiveness:

- How should Officer/CU/Felix accountability be done as part of Council or some other forum e.g. Town Halls?
- How frequently should Council meetings take place, how long should meetings be?
- Why are few individuals bringing business to Council? Is this a bad thing / does this suggest we should rethink how business is brought to Council?
- Do we need to clarify what Subcommittees can decide vs what needs to come to Council?

## Constituent Union governance:

- How can PG representation be implemented in CUs? What is the membership status of PGs in CUs?
- Can CU Governing Documents be more standardised?
- Should CU GD approval be brought under GIB instead of Council?

## Campus representation:

- How can the interests of students based at non-South Kensington campuses be most effectively represented? What are the best structures for this? Should these structures be called 'Constituent Unions'?
- How should such structures be 'plugged in' to ICU democracy through Council, subcommittees, etc?

• How should activities run by campus structures be managed? (CSP vs MG status) How do we support social / events provision at these campuses?

#### Non-Council democratic mechanisms:

- How should referend be used by the Union, and are the regulations for these set out in the Bye Laws fit for purpose?
- How should the Union's new petitions system plug in to Union governance / democratic decision-making?
- Are there any other types of meeting (eg Town Halls, General Meetings) that would be of value from a Union democracy point of view?
